### GENERAL CONDITIONS

1. The tender should be addressed to the Managing Director in a sealed cover with the tender number superscribed on the top of the cover.
2. Each tender shall be accompanied by an E.M.D. of Rs.10,000/- for the supply of Paper by way of demand draft payable at Ernakulam and drawn in favor of “ Kerala State Co-operative Consumers’ Federation Ltd”. Tenders not accompanied by E.M.D. are liable to be rejected.
3. If the supplier got any EMD relaxation through any Government Orders (GOs). In this case, they must attach a copy of the valid certificates and the concerned GOs forgetting the relaxation. If the supplier failed to submit these documents with the tender, the federation will reject the submitted tender without any query.
4. The tender should be in the prescribed form, which can be obtained from the office of the Federation on payment of Rs.100/-+ GST 12%. Tenders, which are not in the prescribed form are liable to be rejected.
5. Intending tenderer should send the tenders so as to reach this office **before 2.00 PM on 22.06.2020**. Tenders received after the specified date / time will be rejected.
6. The tenders will be opened at **3.00 PM on 22.06.2020** at the Head office of the Federation in the presence of tenderers on attendance.
7. **The rates will be considered firm for acceptance till 30.09.2020. Tenders not stipulating period of firmness and tenders with price variation clauses are liable to be rejected.**
8. If any tenderer withdraws from his tender before the expiry of the period fixed for keeping the rates firm for acceptance, the earnest money deposited by him will be forfeited.
9. Tenderers should be prepared to accept orders subject to the penalty clauses for forfeiture of security in the event of default in supplies.
10. All payments to the supplier will be made by account payee cheque. In case payment is required by demand draft, bank charges will have to be borne by the supplier.
11. **Kerala State Co-operative Consumers’ Federation Ltd will accept Tender containing the rate for a single item, in such case the EMD will be Rs.5000/- only.**

12. Ordinarily payments will be made only after the supplies are actually verified and taken into stock. But in exceptional cases, payment against delivery will be made upto 90 percent of the value of the materials at the discretion of the Managing Director, Consumerfed. Payment against documents shall also be considered upto 75% of value of the material at the discretion of the Managing Director, Consumerfed and depending on the rate of discount offered by the tenderer.
13. Final payment will be made only on production of tax clearance certificate relating to sales tax and income tax by the supplier
14. The tenderer is at liberty to quote rate for whole or part of the items required by the Federation.
15. Special conditions if any of the tenderer attached with the tender will not be applicable to the contract unless they are expressly accepted in writing by the undersigned.
16. The undersigned reserves the right to reject any or all the tenders without assigning any reasons thereof.
17. In case of any difference or dispute arises in connection with the contract the same will be decided as per the provisions contained in the Kerala Co-operative Societies Act (21 of 1969). Only the courts of Ernakulam shall have jurisdiction over disputes related to this contract.

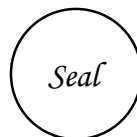
