CONSUMERFED FOR - No.CFED/NBD/1/2020-21**

1. Aspiring Suppliers, who have not obtained the user ID & Password for participating in e-tendering in Consumerfed, may now obtain by giving the details in the website www.tenderwizard.com/CFED.
2. Suppliers can download the e-tender form (tender document).
3. Suppliers can access e-tender form upto 15.3.2021, 2. 00 P.M.
4. Last date for the submission of completed tender document in the e-tender website is 2.00 P.M on 15.3.2021. All mandatory fields/spaces in the tender document or schedules should be filled up.
5. Suppliers can access tender documents on the website, fill them and submit the completed tender document into electronic tender box on the website itself. Supplier should upload only the downloaded documents, without changing the name of the document. Making any modifications in the downloaded documents, except filling the required details, will lead to disqualify the supplier from the tender.
6. The EMD details shall be filled and EMD as DD or requisition for the adjustment of previous EMD should be sent by courier/post to the Managing Director so as to reach before 2.00 P.M on 15.3.2021.
7. After loading and submitting the quote sheet, the supplier should delete the quote sheets from the computer used by them (in case of computers of internet café or if such common shared computers are used) and clear the recycle bin, to avoid others to see the rates quoted by them.

11. Purchase committee will be held on **16/3/2021 at head office** for checking with the submitted samples at Consumerfed Head Office Ernakulam. Tenders in the position of L1, L2, L3 or their authorized representative may attend the sample checking process, if required.

13. Corrigendum will be published in the website for all modifications/corrections, if any.

17. All payments to the supplier will be made by account payee Cheque/RTGS/NEFT. In case payment is required by demand draft, bank charges will have to be borne by the supplier.

Payment will be released upon the receiving material are satisfy the quality standards prescribed by consumerfed and matching with the sample supplied by the supplier at the time of purchase committee and after getting the stock control form and original bill from Triveni Stationery Division Kunnankulam (payment period maximum 30 to 45 days).
19. Special conditions if any of the tenderer attached with the tender will not be applicable to the contract unless they are expressly accepted in writing by the undersigned.
20. The undersigned reserves the right to reject any or all the tenders without assigning any reasons thereof.
21. In case of any difference or dispute arises in connection with the contract the same will be decided as per the provisions contained in

the Kerala Co-operative Societies Act (21 of 1969). Only the courts of Ernakulam shall have jurisdiction over disputes related to this contract.

22. The quoted price should be inclusive of all kind of taxes, duties, freight charges, expenditures for our door delivery which is mentioned here with.
23. Delivery should be made within seven days on receipt of purchase order and deliver all the requirements at **Triveni Stationery Division, Kunnankulam in Thrissur District, Kerala.**
24. If any tenderer withdraws from his tender before the expiry of the period fixed for keeping the rates firm for acceptance, the earnest money deposited by him will be forfeited.
25. Tenderers should be prepared to accept orders subject to the penalty clauses for forfeiture of security in the event of default in supplies.
