Detailed Terms & Conditions

Earnest Money Deposit

1. The party shall be required to deposit Rs.10000/- Earnest Money by way of Bank Draft/Fixed Deposit Receipt/Bank Guarantee drawn in favour of 'Managing Director, Kerala State Co-operative Consumers' Federation Ltd.'
2. The vendor may submit a request for treating the amount due to them from Consumerfed as Earnest Money Deposit and Consumerfed have full right to accept / reject the request. This request may be accompanied along the tender document by the tenderer.
3. EMD furnished by all unsuccessful vendors shall be returned to them without any interest whatsoever, at the earliest after expiry of the final tender validity period but not later than 30 days after conclusion of the contract. EMD of the successful vendor shall be returned, without any interest whatsoever, after receipt of performance security from it as called for in the contract.
4. The firms / institutions / Vendors those who are exempted from Earnest Money Deposit should produce necessary government orders for the same.

Terms & Conditions

1. The validity period of this quotation is for 30 days.
2. Withdrawal from the quotation after it is accepted or failure to supply within a specified time or according to specifications will entail cancellation of the order and purchases being made at the offers expenses from elsewhere, any loss incurred thereby being payable by the defaulting party. In such an event the Consumerfed reserves also the right to remove the defaulter's name from the list of suppliers of Consumerfed for the next two years.

3. Any quotation received after the time fixed on the due date is liable to be rejected.
4. The quotations shall be opened in the presence of the vendors or his authorized representatives. The vendors representative shall furnish the authorization letter of the concerned authority to participate in the quotation.
5. The L1 vendor will be called for negotiation and after only the finalization will be made .
6. L1 vendor should supply the item at IT Division, Consumerfed Head Office, Gandhinagar, Kadavanthara P O, Kochi – 682020 on free of cost.
7. Technical Evaluation of the Server will be conducted by Head Office IT Division
8. The delivery period of the supplies should be within 10 days from the date of confirmed purchase order
9. Payment will be released within 15 days after supply and successful installation with proper Installation Report
10. Payment terms will be 95% on supply and installation and 5% on submission of bank guarantee for an equal amount for 3 years.
11. Delay cut is applicable for delayed supply and will be deducted from the first installment i. e, 5 % from the 95% of first payment.
12. Warranty for the assets minimum 3 years compulsory.
13. Warranty service - Server will be under 3years onsite comprehensive warranty support from the date of installation. The suppliers shall replace the faulty part of the system with same or higher without any additional cost to Consumerfed.
14. Forward an acceptance letter as token of acceptance of the purchase Order within 3 days.
15. Consumerfed have the right to amend or cancel the quotation in part or in full without prior notice at any point of time.
16. Consumerfed has the right to move Server between any units of the Consumerfed. This equipment however will continue to be under warranty at the new location.

17. The vendor will be responsible for any mishap or accident or untoward incidence during the maintenance of machine which may occur due to negligence of the service engineer.
18. The vendor shall be responsible for the discipline and good conduct of their service engineers.
19. Vendor should have minimum of 4 years' experience in the field of Distribution and Service support of servers.
20. The tender has to produce necessary certificates from the Dell \ HP or other Renowned Brands that the tenderer has obtained necessary back end arrangement.
21. The scope of work includes Fault fixing, repairs, replacement of spares and attending to any number of breakdown calls
22. Parts replaced shall always conform to the specification of Original Equipment Manufacturer and Consumerfed's acceptance should always be sought before the part is replaced
23. Special conditions, if any, printed on the quotation sheets of the tenderer or attached with the tender will not be applicable to the contract unless they are expressly accepted in writing by Consumerfed.
24. Any attempt on the part of vendors or their agents to influence the Officers concerned in their favour by personal canvassing will disqualify the tenderers.

26. The vendor have no right, to give, sell, assign or sublet or otherwise dispose of contract to a third party. The vendor may outsource certain noncritical activities in the scope of work like installation of a equipment to a third party after prior written consent from Consumerfed. However, such consent shall not relieve the supplier from any liability or obligation of the contract.

27. Consumerfed does not bind itself to accept the lowest or any quotation. Managing Director, Consumerfed reserve the right to accept or reject any quotation in full or part, and to suspend this process and reject all tenders or part at any time prior to the award of contract.
28. The firm shall not take any advantage of any misinterpretation of the conditions in the tender notice due to typing or any other error and if any in doubt shall bring it to the notice of the Consumerfed authorities without delay. In case of any contradictions, only the printed rules and books should be followed and no claim for the misinterpretation shall be entertained.
29. Each page of the Tender Document shall be signed by person/s on behalf of the organization having necessary authorization/ Power of Attorney to do so.
30. This Quotation is not an offer by Consumerfed but an invitation for vendors response. No contractual obligation whatsoever shall arise from the tender process

FORCE MAJEURE

If the Vendor is unable to comply with the provision of the contract or creative delays due to reason of Force Majeure such as acts of god, acts of public enemy, acts of Government, fires, floods, earthquake, epidemics, restrictions, strikes and freight ernbargoes, the maintenance agency shall immediately inform Consumerfed in writing of his inability. The Consumerfed in receipt of such notice after certification if necessary, may agree to the same as may be reasonable but without prejudice to other terms and conditions of the contract

ARBITRATION

If at any time, dispute or difference whatsoever arises between Managing Director, Consumerfed and the Vendor in connection with this contract, the same shall be settled amicably. In case both the parties are unable to resolve the dispute amicably, the same shall be referred as Arbitration case under KCS act and Rules.

JURISDICTION

The jurisdiction for the purpose of settlement of any dispute or differences whatsoever in respect of or relating to or arising out of or in any way touching this contract or the terms and conditions there or the contraction/interpretation thereof shall be that of Ernakulam jurisdiction only.

COST DETAILS AND VALIDITY:

Prices quoted shall be in Indian Rupees, shall be firm and shall not be subject to exchange rate variations, fluctuations in price, Labour conditions and freights or any conditions whatsoever. The quoted Rate / Cost should be inclusive of all levies/ taxes like Service tax, GST, Educational cess, Sales Tax, Transportation, Customs, Excise, traveling charges etc, if any

PENALTY FOR DEFAULT IN SERVICES:

Any complaint booked will have to be rectified on the next working day. In case the firm fails to rectify within the time frame it has to provide a standby identical system on the next working day before 11.00 Hrs and take parallel action for repairing. If the firm fails to make the system working by any of the two options, penalty of Rs. 500/- (Rupees Five Hundred only) will be imposed per working day per system. If the Servers is not repaired within three working days after reporting the complaint, the penalty charge will be levied at the rate of 1 % per week of value and there after the machine can be repaired from outside at the risk and expense of the firm.

In case of fault where no STAND BY is provided and fault persists beyond ONE WEEK or faulty equipment is taken by vendor for repair and not returned within ONE WEEK after repair, Consumerfed shall be at liberty to get the same repaired from outside source and recover the cost from the Vendor from the performance security deposit.

In case any damage/ loss is caused due to mishandling or improper rectification of fault or otherwise the loss shall be recovered from the vendor.

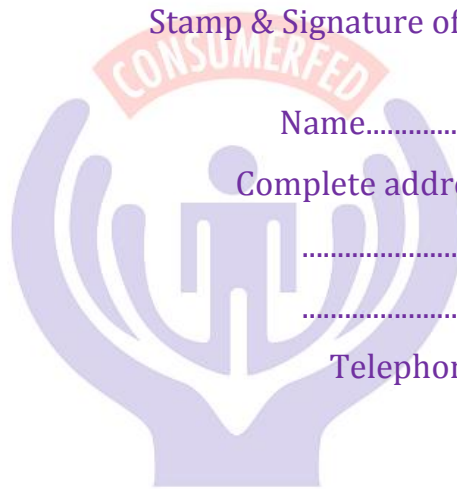

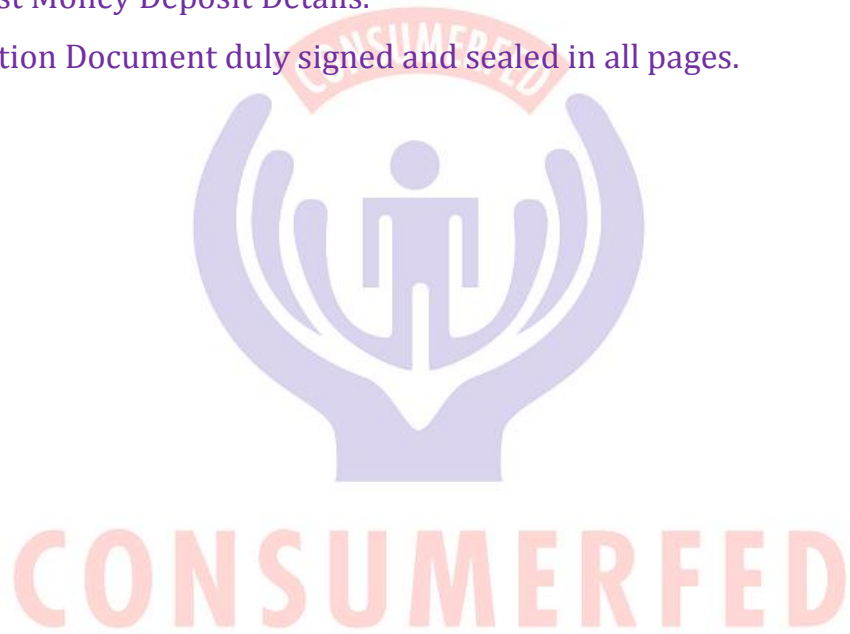

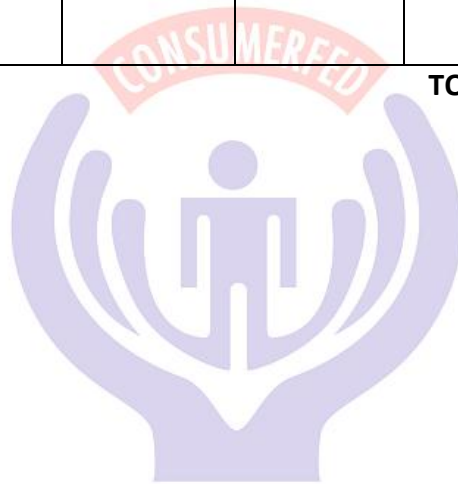
