Detailed Terms & Conditions

Earnest Money Deposit

- The party shall be required to deposit 5% Earnest Money of estimated value of rate quoted in Annexure "A" by way of Bank Draft/Cash/Fixed Deposit Receipt/Bank Guarantee drawn in favour of 'Managing Director, Kerala State Co-operative Consumers' Federation Ltd. The EMD can be remitted by way of cash also. In such cases details of Cash Receipt No: is to be mentioned in the tender form.
- 2. The Tenderer may submit a request for treating the amount due to them from Consumerfed as Earnest Money Deposit and Consumerfed have full right to accept / reject the request. This request may be accompanied along the tender document by the tenderer.
- 3. The firms / institutions / Tenderers those who are exempted from Earnest Money Deposit should produce necessary government orders for the same.
- 4. EMD furnished by all unsuccessful tenderers shall be returned to them without any interest whatsoever, at the earliest after expiry of the final tender validity period but not later than 30 days after conclusion of the contract. EMD of the successful tenderer shall be returned, without any interest whatsoever, after the expiry of the contract.

Terms & Conditions

- 1. The validity period of this tender is for 30 days
- 2. The Rate contract is invited for the supply of UPS , Battery and Inverter for the next one year all over Kerala.
- 3. Acceptance of the tender constitutes a concluded contract. Nevertheless, the successful tenderer must within a fortnight/a month after the acceptance of his tender may execute an agreement at his own cost for the satisfactory fulfillment of the contract, if so required.
- 4. Withdrawal from the tender after it is accepted or failure to supply within a specified time or according to specifications will entail cancellation of the order and purchases being made at the offers expenses from elsewhere, any loss incurred thereby being payable by the defaulting party. In such an event the Consumerfed reserves also the right to remove the defaulter's name from the list of suppliers of Consumerfed for the next two years.
- 5. Any tender received after the time fixed on the due date is liable to be rejected.
- 6. The tenders shall be opened in the presence of the tenderers or his authorized representatives. The tenderers representative shall furnish the authorization letter of the concerned authority to participate in the tender.
- 7. The party agrees to supply the UPS and Battery as per the requirements and specifications of the Consumerfed and shall be of the best quality.
- 8. The warranty period will commence only on confirmation of satisfactory installation of equipment by the Consumerfed. But if the difference between the date of delivery and date of installation is more than 30 days, and the delay is attributable to the Consumerfed then date of delivery shall be considered for commencement of Onsite warranty.
- 9. All the concerned equipment's shall be supplied with the relevant interface cables and necessary standard accessories

- 10. The Supplier cannot refuse to supply the items in the rate contract. Refusal shall be breach of contract and Supplier shall be liable for punishment to the extent of the blacklisting the vendor.
- 11. The rates offered by the tenderer shall be applicable for the delivery anywhere in Kerala. Requests for enhancement of rates once accepted will not be considered except where Consumerfed have, prior to the actual supplies, expressly agreed in writing for any price variation under specified circumstances. Conditions of sale or other special terms and conditions, if any, printed on the tender form of the Supplier or attached with the Suppliers offer or any other letter or paper from the Supplier will not govern this contract nor bind the Consumerfed in any manner whatsoever unless such terms have been expressly accepted by the Consumerfed in writing.
- 12.All the concerned equipment's shall be supplied with the relevant interface cables and necessary standard accessories
- 13. The supply / break down calls registered by users must be attended promptly and if they are not rectified the penalty clause will be applicable.
- 14.Any attempt on the part of tenderers or their agents to influence the Officers concerned in their favour by personal canvassing will disqualify the tenderers.
- 15.Performance Security deposit @ 5% of the invoice amount shall be retained for a period of one year from the date of satisfactory installation for ensuring the performance of the goods supplied. If the performance is not satisfactory the retained amount shall not be released within the stipulated time and Federation have the right to extend the repayment period of the performance security deposit for a period of further period as decided by the Federation and during the extended period if the performance is not satisfactory the performance guarantee will be forfeited.

- 16.The firm shall not take any advantage of any misinterpretation of the conditions in the tender notice due to typing or any other error and if any in doubt shall bring it to the notice of the Consumerfed authorities without delay. In case of any contradictions, only the printed rules and books should be followed and no claim for the misinterpretation shall be entertained.
- 17. This Tender / Request for Proposal (RFP) is not an offer by Consumerfed But an invitation for tenderers response. No contractual obligation whatsoever shall arise from the tender process.

- 19.Each page of the Tender Document shall be signed by person/s on behalf of the organization having necessary authorization/ Power of Attorney to do so.
- 20.Consumerfed does not bind itself to accept the lowest or any quotation. Managing Director, Consumerfed reserve the right to accept or reject any quotation in full or part, and to suspend this process and reject all tenders or part at any time prior to the award of contract.

FORCE MAJEURE

If the tenderer is unable to comply with the provision of the contract or creative delays due to reason of Force Majeure such as acts of god, acts of public enemy, acts of Government, fires, floods, earthquake, epidemics, restrictions, strikes the tenderer shall immediately inform Consumerfed in writing of his inability. The Consumerfed in receipt of such notice after certification if necessary, may agree to the same as may be reasonable but without prejudice to other terms and conditions of the contract

ARBITRATION

If at any time, dispute or difference whatsoever arises between Managing Director, Consumerfed and the Maintenance Agency in connection with this contract, the same shall be settled amicably. In case both the parties are unable to resolve the dispute amicably, the same shall be referred to as Arbitration case under KCS act and Rules.

JURISDICTION

The jurisdiction for the purpose of settlement of any dispute or differences whatsoever in respect of or relating to or arising out of or in any way touching this contract or the terms and conditions there or the contraction/interpretation thereof shall be that of Ernakulam jurisdiction only.

COST DETAILS AND VALIDITY:

Prices quoted shall be in Indian Rupees, shall be firm and shall not be subject to exchange rate variations, fluctuations in price, Labour conditions and freights or any conditions whatsoever. The quoted Rate / Cost should be inclusive of all levies/ taxes like Service tax, GST, Sales Tax, Transportation, Customs, Excise, traveling charges etc, if any
