2. The cost of tender form once paid will not be refunded.
3. Further clarification/corrigendum in this tender regard, if any, will be put up only on the above site. Bidders should regularly visit the above web site to keep themselves updated.
4. The eligible bidders must have GST registration and the quoted rates must be inclusive of all taxes, duties and cesses prevailing, also inclusive of, likely to be levying in future by the State Govt./Central Govt.
5. **Cost of tender form Rs.5,900/- (Rupees Five thousand nine hundred Only) (5000+18 % GST), Non refundable.**
6. **EMD, 1% of the Estimated PAC must be remitted online through E-tender web site or Demand Draft, NEFT, RTGS, Bank Guarantee.**
7. Quantities are tentative and can vary.
8. If any bidder withdraws from his tender before the expiry of the period fixed for keeping the rates for acceptance, the earnest money if any, deposited by him will be forfeited or such action taken against him as consumerfed think fit.
